

**RIVERSIDE HAWKS “RUN FOR THE NATIONALS” APRIL 1, 2017 – May 31, 2017
SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE OR DONATION NECESSARY. A PURCHASE OR DONATION WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS SWEEPSTAKES IS VOID WHERE PROHIBITED BY LAW.

1. **Sponsor.** Riverside Hawks, Hope, Health and Hoops Corporation, 490 Riverside Drive, New York, NY 10027 (“Sponsor”). Donations received from this Sweepstakes will help fund the Riverside Hawks youth basketball team’s travel, accommodations, meals and other ancillary expenses for participation in various summer basketball tournaments.
2. **Entry Period.** The Riverside Hawks “Run for the Nationals” **April 1, 2017 – May 31, 2017** Sweepstakes (“Sweepstakes”) begins April 1, 2017 at 9:00am EST (“Start Date”) and ends May 31, 2017 at 5:00 EST (“Sweepstakes Period”).
3. **Eligibility.** Open to individual legal residents of the 50 United States and the District of Columbia who are at least 13 years old and have reached the age of majority in the individual’s state of residence as of the Start Date. Sponsor and any other party associated with the development and execution of this Sweepstakes, and their respective employees, officers, and directors (and their immediate families and members of the same household) are not eligible to enter.
4. **How to Enter.** Individuals can automatically receive one (1) sweepstakes entry per \$5.00 donation to the Riverside Hawks, Hope, Health and Hoops Corporation made at any location where the Sweepstakes is being promoted during the Sweepstakes Period. Individuals must hand a completed entry to an authorized representative of Sponsor before the end of the Sweepstakes period. All donations are non-refundable. To receive one (1) Sweepstakes entry without making a donation, mail a self-addressed, stamped envelope and a handwritten letter requesting a free Sweepstakes entry, which must be postmarked no later than May 3, 2017, and received no later than May 11, 2017, and include your full name and postal address, and send the request to the Riverside Hawks, Hope, Health and Hoops Corporation (Sweepstakes) at 490 Riverside Drive, New York, NY 10027 (Mail-In Sweepstakes Entry Request). Any request for a Sweepstakes entry to be mailed outside the United States will not be acknowledged. Each Mail-in Sweepstakes Entry Request must be mailed in separately. When you receive a mail-in Sweepstakes entry, you must write your name, address, phone number, and email address on the Sweepstakes entry and mail the original Sweepstakes entry, postmarked no later than May 31, 2017, and received no later than June 4, 2017 to: Riverside Hawks, Hope, Health and Hoops Corporation (Sweepstakes), 490 Riverside Drive, New York, NY 10027. Subject to availability of Sweepstakes entries, individuals can receive up to 20,000 Sweepstakes entries, which is the total number of Sweepstakes entries printed

for the Sweepstakes. Information collected as part of this Sweepstakes will only be used to communicate with entrants about the Sweepstakes or Sponsor's charitable activities.

5. **Prize Draw.** The Sweepstakes consists of one Prize Draw with the potential to win 1st Prize, 2nd Prize or 3rd Prize, as further described below. In order to enter the Prize Draw, you must obtain a Sweepstakes entry using any of the methods described in Section 4 of these Official Rules, and then submit the entry in one of the following ways: (1) No later than May 31, 2017, hand your completed entry and \$5.00 donation, in-person, to an authorized volunteer of Sponsor distributing entries for the Sweepstakes; or (2) write your name, address, phone number, and email address on a mail-in Sweepstakes entry, and mail it to Riverside Hawks, Hope, Health and Hoops Corporation (Sweepstakes), 490 Riverside Drive, New York, NY 10027. All Sweepstakes entries submitted by mail must be postmarked no later than May 31, 2017, and received no later than June 4, 2017. Subject to availability of Sweepstakes entries, individuals can enter the Sweepstakes up to 20,000 times, which is the total number of Sweepstakes entries printed for the Sweepstakes. You must retain a photocopy of any submitted mail-in Sweepstakes entries as proof of your entry. Sweepstakes entries will not be acknowledged.
6. **Selection of Prize Draw Winners.** All entries into the Prize Draw that meet the eligibility requirements set forth in these Official Rules will be considered "Eligible Entries." One (1) entrant will be selected from all Eligible Entries received in a random drawing ("Drawing") as the 1st Potential Prize Winner, one (1) entrant will be selected from all Eligible Entries received as the 2nd Potential Prize Winner, and one (1) entrant will be selected from all Eligible Entries received as the 3rd Potential Prize Winner (each, a "Potential Prize Winner"). The Drawing will be conducted by Sponsor on or about June 15, 2017. Each Potential Prize Winner will be notified by telephone or email on or about three (3) business days after the date of the Drawing. Subject to verification of eligibility and compliance with the terms of these Official Rules, the Potential Prize Winners will be declared the 1st Prize Winner, the 2nd Prize Winner, and the 3rd Prize Winner, respectively (each, a "Prize Winner").
7. **Prizes and Odds.** All Prizes will be sent to Prize Winners approximately four (4) weeks following the date that Sponsor selects the winning Sweepstakes entry pursuant to Section 6. The name (first and last name) of the Prize Winners may be published on Sponsor's Website and Social Media pages.

- a. **Prizes.** The 1st Prize Winner will receive a 12.9-inch iPad Pro (the “1st Prize”), the 2nd Prize Winner will receive a JetBlue Travel Certificate (the “2nd Prize”), and the 3rd Prize Winner will receive an Apple Nike Watch (the “3rd Prize” and together with the 1st Prize and 2nd Prize, the “Prizes”). The Prizes are not transferable or exchangeable for any other prize. The Prizes will be awarded within 30 days of informing the respective Prize Winner, subject to compliance with all requirements of these Official Rules. Sponsor is responsible only for prize delivery; Sponsor is not responsible for prize utility, quality or otherwise. Odds of winning the 1st Prize, 2nd Prize or 3rd Prize are based on the number of eligible entries received, but are no less than 1 in 20,000.
- b. **Taxes & Fees.** Taxes and fees, if any, are the sole responsibility of the Winner; taxes may be withheld by Sponsor if required by law.
8. **Verification of Winner and Delivery of Prize.** Each Prize Winner may be required to sign an affidavit of eligibility and liability release and, where permitted, a publicity release. Each Prize may be awarded to an alternate winner selected by random drawing if the Potential Prize Winner cannot be reached within five (5) days after Sponsor or any other party associated with the development and execution of this Sweepstakes contacts the Potential Prize Winner by telephone or email, or if the Prize is returned as undeliverable, or Potential Prize Winner cannot be reached by telephone or email, or if the affidavit/release is not returned within ten (10) business days after it is sent to the Potential Prize Winner. If the Prize is won by a minor, it may be awarded in the name of a parent or legal guardian in Sponsor’s sole discretion. All entries are subject to verification at any time. Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility in a form acceptable to Sponsor to participate in this Sweepstakes. In the event of a dispute as to the identity or eligibility of any Potential Prize Winner based on an email address, the entry will be deemed to have been submitted by the authorized account holder of the email address submitted at the time of entry. The authorized account holder of an email address is defined as the person who is assigned an email address by an internet provider, online service provider, or other organization (e.g. business, educational institute, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address. Failure to provide such proof in a timely manner may result in disqualification. Potential Prize Winners may be required to provide proof in a form acceptable to Sponsor that he/she is the authorized account holder of the email address or phone number associated with an entry.
9. **Entry Disqualification.** Sponsor reserves the right, at its sole discretion, to disqualify anyone from this Sweepstakes or any other promotion conducted now or in the future by Sponsor if he/she tampers with the entry process or if his/her misconduct affects the integrity of the

Sweepstakes. Sponsor is not responsible for, nor is Sponsor required to count, in its sole and absolute discretion, late, lost, misdirected, or unlawful entries that are submitted. Use of automated devices or methods to enter the Sweepstakes is prohibited.

10. Limitation of Liability. Sponsor, in its sole discretion, reserves the right to suspend, cancel or modify the Sweepstakes without notice or liability if the integrity of the Sweepstakes is compromised in any manner as determined by Sponsor, or if the Sweepstakes is not capable of being conducted as intended by Sponsor. If the Sweepstakes, or any part of it, is discontinued for any reason, Sponsor, in its sole discretion, may elect to hold a random drawing from among all Eligible Entries received up to the date of discontinuance for any or all of the Prizes offered herein. No more than the stated number of prizes will be awarded. In the event that production, technical, seeding, programming or any other reasons cause more than the stated number of prizes as set forth in these Official Rules to be available and/or claimed, Sponsor reserves the right to award only the stated number of prizes by a random drawing among all legitimate, un-awarded, eligible prize claims. Any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event shall such claims, judgments, or awards include attorney's fees.

11. Release and Indemnity. As a Sweepstakes entrant, you agree to release Riverside Hawks, Hope, Health and Hoops Corporation and any parties associated with the development and execution of this Sweepstakes, and each of their respective subsidiaries, affiliates, successors, licensees, and assigns, and their respective officers, directors, and employees (collectively, the "Indemnitees"), from any and all loss, liability, damage, cost, or expense arising out of or in connection with, this Sweepstakes, including, but not limited to, any suspension, modification or cancellation of the Sweepstakes, and/or acceptance or use of any prize or any other part of any prize, including liability for personal injury, damages or loss. Furthermore, by participating in the Sweepstakes, you agree to indemnify, defend and hold harmless Indemnitees, from and against any and all claims, losses, damages, liabilities, and costs and expenses (including reasonable attorneys' fees) which arise out of any breach of these Official Rules.

UNDER NO CIRCUMSTANCES AND UNDER NO LEGAL THEORY, TORT, CONTRACT, OR OTHERWISE, SHALL INDEMNITEES BE LIABLE FOR ANY DAMAGES WHATSOEVER, INCLUDING, BUT NOT LIMITED TO, DIRECT, INDIRECT, INCIDENTAL, PUNITIVE, OR CONSEQUENTIAL DAMAGES, EVEN IF IT HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES OR CLAIMS.

12. Governing Law, Forum and Venue. This Agreement shall be construed and governed by the laws of the State of New York, without regard to conflict of law principles. All disputes relating to or arising under this Agreement must be brought in the state and federal courts

located in New York County, New York. The parties consent to venue in, and the personal jurisdiction of, these courts.

13. Except where prohibited, you agree that any and all disputes, claims and causes of action arising out of or connected with the Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in New York County, New York, without regard to any conflicts of law principles.
